ARTICLE IX – OFFICERS

Section 9.01. Number, Designation, and Qualification. The Officers of the Corporation shall be as follows:

President Vice President Secretary

And such other Officers as may be elected in accordance with the provisions of Section 6.03 of Article VI. No person shall be elected by the membership to more than one of the offices listed in this section. Officers shall be natural persons of full age.

Section 9.02. <u>Nominations.</u> Pursuant to Section 2.02 of Article V, the Nominating Committee shall designate candidates for Officers to be elected at meetings of the membership according to the procedures prescribed therein.

Section 9.03. Election and Term of Office. The Officers and the two (2) additional members of the Executive Committee shall be elected to a two (2) year term by the membership at the election meeting. If nominations for the respective offices have been received as therein provided, only candidates receiving the highest number of votes for each office from all of the eligible voting members of the Corporation shall be elected. Each elected member of the Board of Directors shall hold his or her respective office until his or her successor shall have been elected and qualified, or until his or her earlier death, resignation, or removal.

Section 9.04. The President. The President shall be the Chief Elected Officer of the Section, and, subject to the control of the Officers, shall perform all duties customary to that office, preside at all meetings of the Section, and of the Executive Committee, and in his or her absence, appoint a Chairperson to preside over such meetings. The President shall supervise and control all affairs of the Section in accordance with policies and directives approved by the Officers. The President shall appoint such committees as shall in his or her judgment be necessary, approve the committee members, and shall designate the Chairperson thereof. In the event of the absence or temporary disability of the President, the Vice-President shall assume the duties of the President.

Section 9.05. The Vice-President. The Vice-President shall keep or cause to be kept the accounts of the Section, and shall collect or direct the collection of all monies belonging to or due the Section, and shall deal with the same under the direction of the Officers. The Vice-President shall have the authority to sign all checks and withdrawal funds of the Section for the purposes of paying all just claims and accounts. The Vice-President shall submit a complete written financial report to the Board of Directors and to the membership annually. The Vice-President shall serve, as Chairperson of the Hall of Fame and Club Relations Committees comprised of PGA members in good standing. In the event of the absence or temporary disability of the Vice-President, the President shall perform the duties of the Vice-President.

Section 9.06. The Secretary. The Secretary shall keep or cause to be kept the minutes of all Section membership meetings and all Executive Committee meetings. The Secretary shall keep a roll of all members and apprentices, and take care of all correspondence and papers pertaining to or changes in the Section and/or National Constitution and By-Laws, and report such amendments to the President for approval. The Secretary will be the Chairperson of the Membership, Junior Golf and Education Committees comprised of PGA members in good standing. In the event of the absence or temporary disability of the Secretary, the Vice-President shall perform the duties of the Secretary.

Section 9.07. <u>Director – Tournaments</u>. The Director of Tournaments shall serve as Chairperson of the Tournament Committee. The Director of Tournaments shall submit to the President for approval a Tournament Committee comprised of PGA members in good standing. The Director of Tournaments shall perform such other duties as may from time to time be assigned to him or her by the Board of Directors or by the President.

Section 9.08. <u>Director – Section Affairs</u>. The Director of Section Affairs shall serve as Chairperson of the Special Awards, Scholarship and Growth of the Game Committees comprised of PGA members in good standing. The Director of Section Affairs shall perform such other duties as may from time to time be assigned to him or her by the Board of Directors or by the President.
